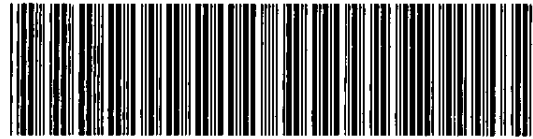



1. Introduction. David Kirk, being duly sworn, deposes and says:


