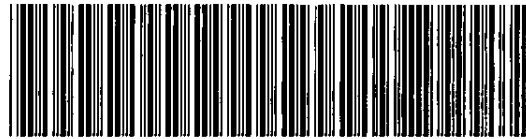

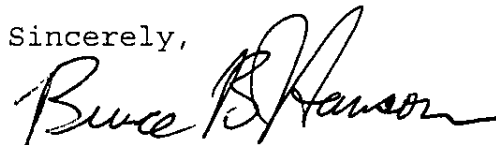

ARTICLE I. NAME

The name of this corporation is MAMRUS, INC.
