

**Article 3. Location.** The principal place of business and the mailing address of the Corporation 438 Lexingdale Drive, Orlando, Florida 32828, U.S.A.


**Article 4. Stock.** The Corporation shall have the authority to issue 1,000,000 shares of common stock.


