

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles of the formation of a corporation in the accordance with the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is: invirtux incorporated.

ARTICLE II - NATURE OF BUSINESS

The general nature of the business to the rendered by this corporation is any lawful purpose permitted by the laws of the State of Florida.

ARTICLE III - PRINCIPAL OFFICE

The manner and form, as well as relevant terms, conditions and details hereof, shall be determined by the Shareholders of this corporation; provided, however, that such regulatory or restrictive provisions shall not affect the rights of third parties without actual notice thereof, unless the existence of such provisions shall be plainly written upon the certificate evidencing the ownership of said stock.
