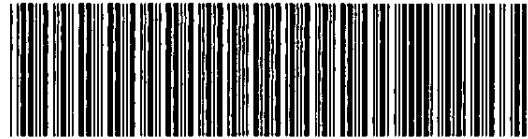



- FIRST: The name of the corporation is RUE BAYOU, INC. (the "Corporation").
