ARTICLE IV - INITIAL PRINCIPAL OFFICE AND REGISTERED AGENT

ARTICLE V - MANAGEMENT BY SHAREHOLDERS

Each shareholder shall be entitled to one vote in person, or by proxy, for each share of voting stock held by him. A majority of the outstanding shares of the corporation entitled to vote, represented in person or by proxy, shall constitute a quorum at any meeting of the shareholders for the management of the business of the corporation. All actions which the Florida Business Corporation Act reserves to the Board of Directors are hereby reserved to the shareholders, including, without limitation, the adoption of the initial bylaws of the corporation, the issuance of any emergency bylaws of the corporation; the issuance of stock; is reserved to the shareholders.

ARTICLE VI- SPECIAL MEETINGS

Special meetings of shareholders may be called if the holders of not less than forty percent (40%) of all of the votes entitled to be cast on any issue proposed to be considered at the proposed special meeting sign, date and deliver to the corporation's secretary one or more written demands for the meeting describing the purpose or purposes for which it is to be held.

ARTICLE VII - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share (as nearly as may be done without the issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VIII - INDEMNIFICATION

This corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE IX - TERM OF EXISTENCE

This corporation is to exist perpetually.


