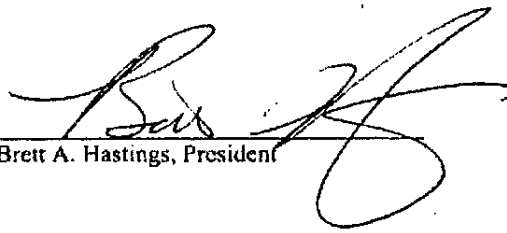
ARTICLES OF AMENDMENT

1. The Name of the corporation is: Brett Hastings, P.A. (the "Corporation").
2. The date of filing of the Articles of Incorporation of the Corporation was April 29, 2011 and assigned document number P11000041851.
