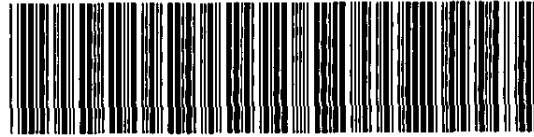

**Name**

The name of this corporation is RDS USA PRODUCTION, INC.

**Article II**


