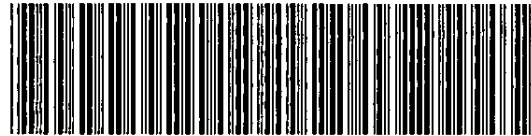

The undersigned incorporator has caused KELLY A. PONCHERI, D.P.M., P.A. to adopt the following Articles of Incorporation in accordance with Chapter 621, Florida Statutes:

ARTICLE I
NAME

The name of the corporation shall be *Kelly A. Poncheri, D.P.M., P.A.*

ARTICLE II
ADDRESSES

ARTICLE III
PURPOSE

To engage in and carry on the practice of podiatry; to diagnose ailments of the human foot and leg by medical, surgical, palliative and mechanical means, to treat and prescribe for such ailments and to perform surgery and prescribe drugs in connection with the practice of podiatry, as defined and limited by Chapter 461, Florida Statutes. To rent, own, hold title to, use, convey, mortgage, sell, pledge, and otherwise employ and invest in real estate, mortgages, stocks, bonds, or any other type of investments, and any and all types and kinds of personal property necessary for the rendering of professional podiatry services, and to carry on any business in connection therewith and incident thereto not otherwise forbidden by the laws of the State of Florida.

CAPITAL STOCK

The corporation is hereby authorized to issue 1,000 shares having a par value of \$.01 per share.

ARTICLES OF INCORPORATION
KELLY A. PONCHERI, D.P.M., P.A.

- (a) No stock of the corporation shall issue to any person who is not duly licensed or otherwise legally authorized to render professional podiatry services in the State of Florida.
- (b) No shareholder of the corporation shall enter into a voting trust agreement or any other type of agreement vesting another person with authority to exercise the voting power of any or all of his stock unless the other person is duly licensed or otherwise legally authorized to render professional podiatry services in the State of Florida.
- (c) If any officer, shareholder, agent or employee of the corporation shall become legally disqualified from rendering professional podiatry services in the State of Florida accept employment that, pursuant to existing law, places restrictions and limitations upon his continued rendering of such professional podiatry services, such officer, shareholder, agent or employee shall sever all employment with, and financial interest in, the corporation within thirty (30) days.
- (d) No stock of the corporation shall be sold or transferred except to an individual who is eligible to be a shareholder of the Corporation or to the personal representative or estate of a deceased or legally incompetent shareholder. The personal representative or estate of such shareholder may continue to own such stock but shall not be authorized to participate in any decisions concerning the rendering of professional services.

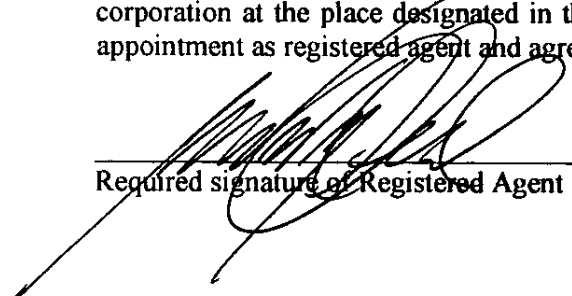

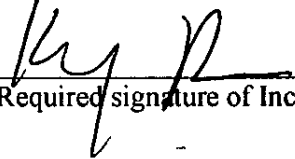

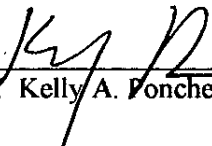
