We, the undersigned, do hereby associate ourselves together and subscribe These Articles of incorporation for the purpose of forming corporation under the laws of the State of Florida, Chapter 607 subject to the following provisions:

#### ARTICLE ONE

The name of the corporation shall be:

This corporation shall have perpetual existence and may engage in any activity or business permitted under the law of the United States and of the State of Florida.

The general nature of the business to be transacted by this corporation shall be:

All or any part of the capital stock may be paid for either in lawful monies of the United States of America, or in other assets transferred to the corporation, at a true valuation as of the exchange for stock.




