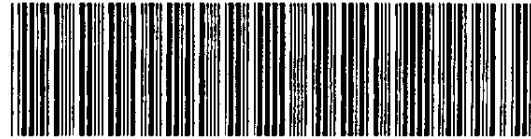

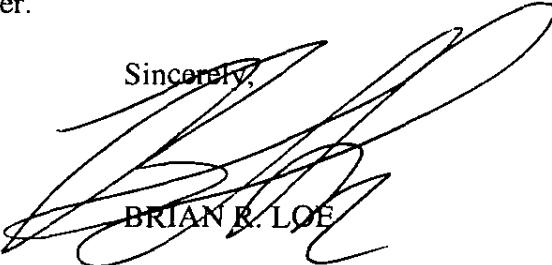

- ARTICLES OF INCORPORATION -

In compliance with the requirements of F.S. Chapter 607, the undersigned, JENNIFER SWEENEY, being a natural person, does hereby act as an Incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business Corporation.

ARTICLE I

The name of the Corporation is ABATEMENT CENTRAL, INC.

ARTICLE II

The existence of the Corporation shall begin upon the filing and acceptance of these articles by the Secretary of State of the sovereign State of Florida and shall be perpetual.

ARTICLE III

The mailing address of the Corporation is 35119 Huff Road, Eustis, Florida 32736. The principal office of the corporation is at 35119 Huff Road, Eustis, Florida 32736. The purpose of the corporation is a for profit enterprise providing state licensed abatement contracting services and all other associated and related for profit activity together with any and all purposes permitted to for profit corporations under Chapter 607 of Florida Statutes.

ARTICLE IV

The maximum number of shares of stock that this company is authorized to issue and have outstanding at any one time is 1,000 shares of voting common stock having no par value. Transfer of any share of this class of stock is subject to a right of first refusal of the Corporation and the other shareholders of said class of stock. All common shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share upon all matters on which shareholders have the right to vote.

ARTICLE V

The initial street address of the Corporation's registered office is 3074 West Lake Mary Blvd, Lake Mary FL 32746. The initial registered agent for the Corporation at that address is BRIAN R. LOE, attorney at law. The board of directors may move the registered office and change the registered agent from time to time as it deems appropriate.

ARTICLE VI

The Corporation shall have one director initially. The number of directors may be increased or diminished from time to time by the by-laws adopted by the shareholders but shall never be less than one.

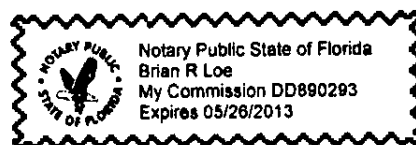
