In compliance with the requirements of F.S. Chapter 607, the undersigned, JENNIFER SWEENEY, being a natural person, does hereby act as an Incomplete in adopting and filing the following Articles of Incorporation for the purpose for FORIOR

#### ARTICLE I

The name of the Corporation is ABATEMENT CENTRAL, INC.

#### ARTICLE II

The existence of the Corporation shall begin upon the filing and acceptance of these articles by the Secretary of State of the sovereign State of Florida and shall be perpetual.

#### ARTICLE III

The mailing address of the Corporation is 35119 Huff Road, Eustis, Florida 32736. The principal office of the corporation is at 35119 Huff Road, Eustis, Florida 32736. The purpose of the corporation is a for profit enterprise providing state licensed abatement contracting services and all other associated and related for profit activity together with any and all purposes permitted to for profit corporations under Chapter 607 of Florida Statutes.

#### ARTICLE IV

The maximum number of shares of stock that this company is authorized to issue and have outstanding at any one time is 1,000 shares of voting common stock having no par value.
