The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms a profit corporation (the "Corporation") under the Florida Business Corporation Act (the "Act"), as follows:

**I.
Name**

The name of the Corporation is Spectrum Consulting Engineers, Inc.

**II.
Term of Existence**

The date when corporate existence will commence is May 6, 2011 in accordance with Section 607.0203(1) of the Act. The Corporation will have perpetual existence thereafter.

Principal Office**

Capital Stock**

The power to adopt, alter, amend or repeal bylaws will be vested in the Corporation's Board of Directors.


XI.


