In compliance with the requirements of Fla. Stat., Ch. 607, et seq., the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing these Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation (the "Corporation") is Your Move Inc.

ARTICLE II

The existence of the Corporation shall be perpetual and shall commence on the date of filing with the Florida Department of State, Division of Corporations.
