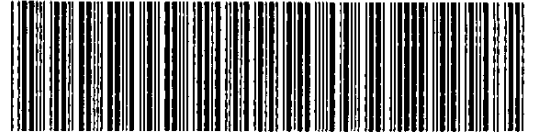

ARTICLE I. NAME

The name of this corporation is BOXBLADE INC.

ARTICLE II. DURATION

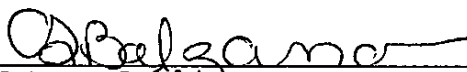

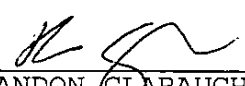
