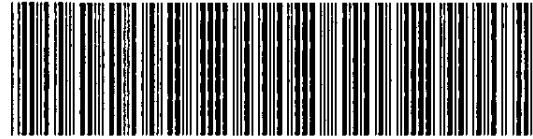

ARTICLES OF INCORPORATION

OF

CAREFREE UV, INC.

- Article I: The name of the corporation (the "Corporation") is Carefree UV, Inc.
- Article II: The principal place of business and the mailing address of the Corporation is:
131 Radcliff
Staten Island, New York 10305
- Article III: The Corporation is organized for the purpose of transacting any and all lawful business.
- Article IV: The Corporation shall have authority to issue a hundred million (100,000,000) shares of capital stock par value of \$0.001 per share of which ninety million (90,000,000) shares shall be designated "Common Stock," and ten million (10,000,000) shares shall be designated "Preferred Stock."

Common Stock. Each share of Common Stock shall entitle the owner thereof to vote at the rate of one vote for each share held. All persons who acquire shares of Common Stock in the Corporation shall acquire such shares subject to the provisions of these Articles of Incorporation and the Bylaws of the Corporation.

Preferred Stock. The board of directors of the Corporation (the "Board of Directors") shall have authority to prescribe and issue the Preferred Stock in one or more series and to prescribe the number of shares constituting and the designation of each such series of Preferred Stock and the rights, voting powers, designations, preferences, privileges, limitations, dividend rights, dividend rates, conversion rights, terms of redemption (including sinking fund provisions), redemption prices, and liquidation preferences; provided, however, that, if more than one series of Preferred Stock is issued, the Board of Directors shall, by resolution, prescribe a distinguishing designation for each such series; and provided further, that the rights prescribed by the Board of Directors with respect to voting powers, designations, preferences, limitations, restrictions, relative rights, and distinguishing designations must be described in a resolution of the Board of Directors. Prior to the issuance of any series of Preferred Stock, a certificate describing such rights must be filed in accordance with Florida law.

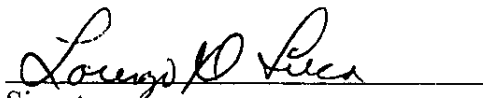
