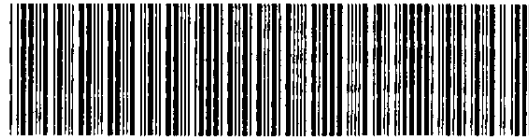

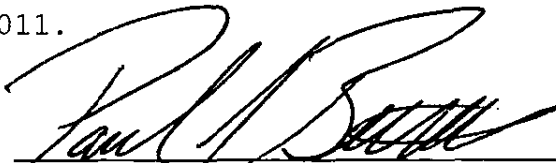
**ARTICLE NINE

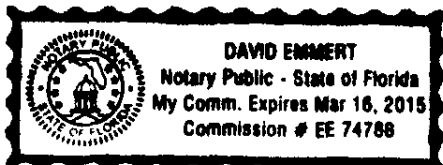

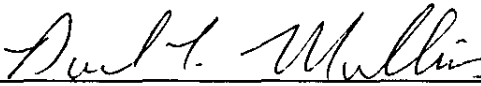
