## ARTICLES OF INCORPORATION 2011 HAY 12 PM 2: 15 OF

The undersigned, the authorized representative of the shareholders of the Company formed under Chapter 607, Florida Statutes (2002), adopts the following Articles of Incorporation for such Company (Emerald Coast Antiques, Inc.):

#### ARTICLE I NAME
