ARTICLES OF INCORPORATION

OF

T INFO SYSTEMS INC.

The undersigned, acting as the sole incorporator, desiring to form a corporation for profit pursuant to the Florida General Corporation Act, adopts the following Articles of Incorporation:

<u>ARTICLE I -- NAME OF CORPORATION</u>

The name of this corporation is **T INFO SYSTEMS INC**, and its principal place of business shall be located at 8402 Ivy Mill Way, Tallahassee, Florida 32312-7038.
