ARTICLE I

The name of the corporation is CXR Corp. (hereinafter the "Corporation").

ARTICLE VI

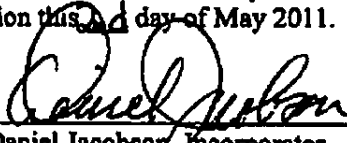
