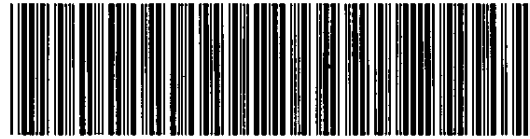

**STATEMENT OF FACT
UNDER PENALTY OF PERJURY**

This resignation is made by James Donald Fugate after discovering that Michael Lewandowski, the owner of M & L Select Autos, Incorporated, without legal authorization added Mr. Fugate as the Registered Agent and President for M & L Select Autos, Incorporated. This illegal action taken by Mr. Michael Lewandowski is one illegal action in an array of illegal actions taken by Mr. Michael Lewandowski over the last few months. The facts below provide the reader with an oversight as to Mr. Michael Lewandowski's recent illegal conduct, and this factual statement is being submitted with Mr. James Donald Fugate's Resignation as Registered Agent and President of M & L Select Autos, Incorporated, as evidence that Mr. Fugate never in any fashion authorized Mr. Michael Lewandowski to add Mr. Fugate to the corporate structure of M & L Select Autos, Incorporated, at any time whatsoever, in any capacity whatsoever. The following facts reflect how Mr. Fugate discovered that he was listed as Registered Agent and President of M & L Select Autos, Incorporated, and further evidences what actions Mr. Fugate is taking to remedy Mr. Lewandowski's illegal conduct.

James Donald Fugate on his travel home after work on the evening of Tuesday, April 15, 2014, attempted to use his Lamb of God Ministries, Inc., company debit card to purchase gas, however, the card was declined. Upon arriving at home Mr. Fugate investigated the matter and discovered that on Tuesday, April 15, 2014, Michael Lewandowski accessed <http://www.sunbiz.org> and without lawful authorization filed on-line an erroneous amended annual report for the Lamb of God Ministries, Inc., Document Number N15678, wherein he removed all active board members, and added himself and other unauthorized individuals to the corporate board. Mr. Lewandowski then printed the amended annual report and presented the document to TD Bank at Lake Placid Florida with corporate minutes allegedly created by one Dorothy J. Sweatt, and advised TD Bank in Lake Placid Florida that he, Michael Lewandowski, was authorized to close the company bank account. TD Bank accepted Mr. Lewandowski's presentation and closed the company's bank account, and transferred \$5,442.73 to a new account which Mr. Lewandowski opened with TD Bank in the company's name. The new bank account assigned Mr. Lewandowski as the sole authorized person to make transactions on the account.

On the morning of April 16, 2014 Mr. Fugate and Secretary of the Lamb of God Ministries, Inc., Rocky Cioffi, went to TD Bank in Broward and cleared the matter up. The new account that Mr. Lewandowski opened was closed by the bank, and a new account was opened for the company. Fraud was reported to the Bank, and upon returning to the company office in Pompano Beach Florida the Broward Sheriff Office was called and a report of fraud and theft was made by Mr. Fugate per the Lamb of God Ministries, Inc., board's instructions. Broward Sheriff Report #11-1404-004072. On April 17, 2014 Mr. Fugate travelled to the Lake Placid Florida Police Department and met with Office Cooper Badge Number 6245 who completed a police report documenting the TD Bank Fraud and Theft by Michael Lewandowski. Police Report Number: LPPD140FF000193.


**STATEMENT OF FACT
UNDER PENALTY OF PERJURY**

On April 18, 2014 it was also discovered that on March 11, 2014 Mr. Michael Lewandowski also went on <http://www.sunbiz.org> and committed yet another incident of fraud in relation to his personal car dealership business (M & L Select Autos, Inc.) which has adversely affected Mr. James Donald Fugate and the Lamb of God Ministries, Inc. Investigation into this matter reveals that on March 11, 2014 Mr. Lewandowski went on to <http://www.sunbiz.org> and removed himself from the corporation structure of his personal car dealership business, and without authorization added Mr. James Donald Fugate as the Registered Agent and President of M & L Select Autos, Inc. It is noted that Mr. Fugate has never been associated with M & L Select Autos, Inc., in any capacity whatsoever, and it is unknown as to why Mr. Lewandowski would have added Mr. Fugate to that corporate business structure. However, further investigation reveals that on January 6, 2014 Mr. Lewandowski's Dealership License was suspended for failure to carry the required business insurance, by the Florida Department of Motor Vehicles and Highway Safety licensing division. Speculation suggests that Mr. Lewandowski fraudulently listed Mr. Fugate as being associated with M & L Select Autos, Inc., in an effort to operate that business under the false guise of a new president, who unlike Mr. Lewandowski, has good standing within the business community. Additionally, yet further investigation revealed that Mr. Lewandowski also illegally altered the bill of sale for two vehicles that are owned by the Lamb of God Ministries, Inc.; placed an after the fact lien on one of the vehicles, and then forged Mr. James Donald Fugate's signature on those two documents. These vehicles were purchased from M & L Select Autos, Inc., by the Lamb of God Ministries, Inc., prior to the aforementioned forgery.

On Friday, April 18, 2014 Mr. Fugate contacted the Florida Department of Corporations Tallahassee Office, and discussed Michael Lewandowski's <http://www.sunbiz.org> fraudulent activities with Investigator Lee Yarbrough (850) 245-4956. Mr. Yarbrough is presently conducting an investigation so the criminal charge of fraud against Michael Lewandowski for his April 15, 2015 activities aforementioned with regard to <http://www.sunbiz.org> can be instituted. Moreover, on that same date of April 18, 2014 Mr. Fugate contacted Mr. Anthony Ramirez (561) 640-6826 who is the Compliance Officer for the Florida Department of Highway Safety and Motor Vehicles Licensing Division to file a complaint against Mr. Lewandowski regarding the aforementioned, and Mr. Fugate's resignations as Registered Agent and President for M & L Select Autos, Incorporated, along with this statement of fact are also being submitted by Mr. Fugate on this date.

I, James Donald Fugate, do hereby declare under the penalty of perjury that the facts and statements made in this document are true and correct.
