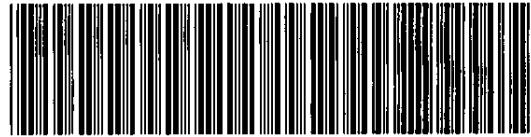



**ARTICLE I





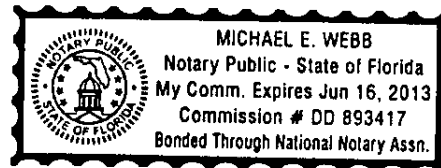
