**ARTICLES OF INCORPORATION  
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation is: CNC Communications, Inc.

**ARTICLE II**

The street address of the principal office of the Corporation is: 230 A1A North, Ponte Vedra Beach, FL 32082.

**ARTICLE III**

The maximum number of shares this Corporation is authorized to issue is 10,000, par value \$.01 per share, all of which shall be Common Shares.
