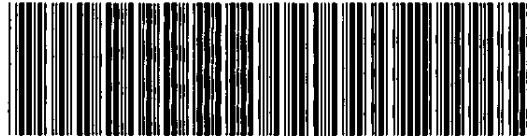

Pursuant to Chapter 607 and/or Chapter 621, Florida Statutes, the undersigned hereby submit the following Articles of Incorporation for a for profit corporation.

**ARTICLE I – NAME**

The name of the corporation shall be: BB & C CHRISTIAN ACADEMY, INC.
