ADDENDUM "A"

to Article IV of the Articles of Incorporation of BravaCo Inc.

The relative rights, preferences, and limitations of the common voting shares and common non-voting shares are to be the same, except that the holders of the common voting shares shall exclusively possess voting power for the election of directors and for all other purposes, and the holders of the common non-voting shares shall not be entitled to vote at any election of directors or for any other purpose; provided however, that each share of the common non-voting stock shall entitle the holder thereof to one vote in every case where such vote is expressly required by statute.
