**ARTICLES OF AMENDMENT
TO ARTICLES OF INCORPORATION OF
SECURID SOLUTIONS, INC.**

SecurID Solutions, Inc., a Florida corporation (the "Corporation"), hereby certifies as follows:

1. The Articles of Incorporation of the Corporation are hereby amended by deleting the present form of Article I in its entirety and by substituting, in lieu thereof, the following:

**ARTICLE I
Corporate Name and Principal Office**

The name of this corporation is SecurID Solutions, Inc. and its principal office and mailing address is 124 Adalia Ave., Tampa, FL 33606.

2. The foregoing amendment shall become effective as of the date of filing with the Florida Department of State, Division of Corporations.

3. The amendment recited in Section 1 above has been duly adopted in accordance with the provisions of §607.1006, Florida Statutes on June 20, 2011, the written action to amend the Corporation's Articles of Incorporation having been approved by the holders of all issued and outstanding shares of the Corporation's common stock, representing sufficient votes to authorize such action. The Corporation has no voting groups other than the above referenced common stock shareholders.
