





ARTICLE I

The name of this Corporation is MORA PROFESSIONAL SERVICES, INC.

ARTICLE II

The specific nature of the business to be transacted by the Corporation is as follows:

Medical Consulting

The Corporation may engage in any activity or business permitted by the Laws of the United States and of this State.




