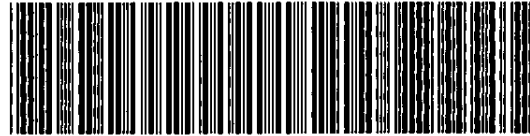



ARTICLES OF INCORPORATION OF

ARTICLE I

Name of Corporation

The name of this corporation is CREATIVE HAIR & SUPPLY INC.

ARTICLE II

Purpose





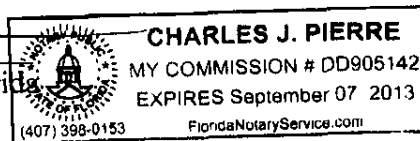
