ARTICLES OF INCORPORATION
OF
SHENG TAI INC.

Pursuant to Chapter 607 of the Florida Statute (the "Florida Business Corporation Act"), the undersigned, hereby adopts the following Articles of Incorporation:

ARTICLE I NAME AND PRINCIPAL OFFICE

The name of the corporation shall be SHENG TAI INC. (hereinafter the "Corporation"), and the principal office shall be at 15303 Amberly Dr., Suite C-4, Tampa, FL 33647.
