

# ARTICLES OF INCORPORATION OF CONDO FACTS CORP

#### **ARTICLE I**

#### NAME

The name of this corporation is:

Condo Facts Corp



#### ARTICLE II

#### DURATION

This corporation is to exist perpetually. It shall commence its existence upon the filing of these Articles of Incorporation.

#### **ARTICLE III**

#### **PURPOSE**

This corporation is organized for the purpose of transacting any and all business permitted under the laws of the United States of America and the laws of the State of Florida.

#### **ARTICLE IV**

#### **CAPITAL TO BEGIN BUSINESS**

This corporation is authorized to issue one hundred (100) shares at five dollars (\$5.00) dollars par value.

#### **ARTICLE V**

#### PREMPTIVE RIGHTS

Every shareholder, upon the sale for cash on any new stock of this corporation of the same class, class or series as that which he already holds, shall have the right to purchase his prorate share thereof (as nearly as may be done without issuance of fractional shares) at the price which is offered to others.
