ARTICLES OF INCORPORATION

OF

ARTICLE 1 - NAME

The name of this corporation is: KEEPING IN TOUCH, INC.

ARTICLE II - DURATION

This corporation is to exist perpetually and it shall commence its existence as of the date of subscription and acknowledgment, provided such date is within five days from the date of filling, otherwise, on the date of filling.
