ARTICLES OF INCORPORATION

SECRETARY DE STATE

The undersigned, for the purpose of forming a corporation under the provisions of Chapter 60% of the Florida Statutes, hereinafter referred to as the Corporation, hereby agree to the following:

ARTICLE I Name and Address

The name of the Corporation shall be **SKYWAY DONUTS**, **INC.** and its mailing address is 13 Fourth Street, Barrington, RI 02806.

ARTICLE II Purpose and Powers

Section 1. The Corporation is formed for the single purpose of operating a Dunkin' Donuts franchise within Pinellas County, Florida.

Section 2. The Corporation may exercise all powers, rights and privileges conferred on corporations pursuant to the laws of the State of Florida.
