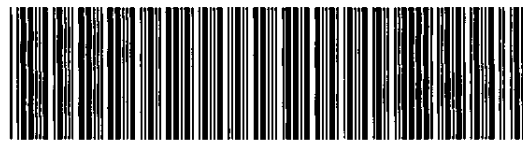



1. Introduction. Todd Durant, being duly sworn, deposes and says:


