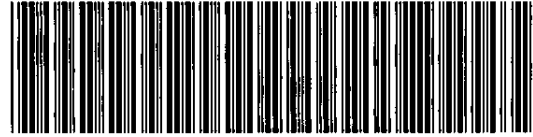



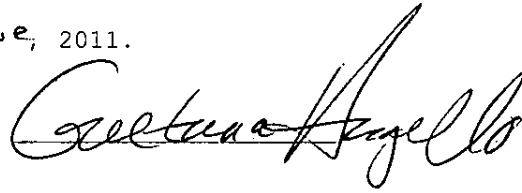
ARTICLE IV

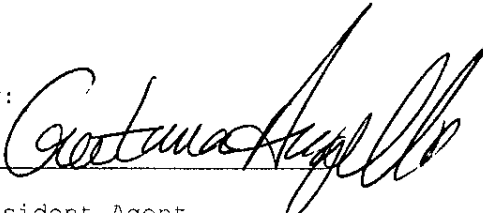
