ARTICLE I
NAME

The name of this corporation is **MITA'S CARDS AND GIFTS INC.**, whose principal place of business and mailing address is 8237 Pine Island Road, Tamarac, Florida 33321.

ARTICLE II
DURATION

This corporation shall have perpetual existence and these Articles are effective upon signing.

ARTICLE III
