

ARTICLES OF AMENDMENT

FOR

FIRST GUARDIAN HEALTH GROUP INC.

Pursuant to Florida Statutes, the following is submitted:

1. The name of this corporation is:

First Guardian Health Group Inc.

2. The Articles of Incorporation are amended by striking therefrom Article II, in its entirety, and inserting in place thereof the following:

ARTICLE II - PRINCIPAL PLACE

The principal place of business and mailing address of the Corporation shall be: 2030 S. Douglas Road, Suite 202, Coral Gables, FL 33134.

3. The Articles of Incorporation are amended by striking therefrom Article III, in its entirety, and inserting in place thereof the following:

ARTICLE III - CAPITAL STOCK

This Corporation is authorized to issue two (2) classes of capital stock designated Class A Common Stock and Class B Common Stock. Class A Common Stock shall be non-voting Stock. Class B Common Stock shall be voting Stock. The number of shares of Class A Common Stock authorized to be issued shall be one thousand (1,000), par value \$.001.
