**ARTICLES OF INCORPORATION OF**  
**SHARON JAQUITH, P.A.**

1. The name of this Corporation is **SHARON JAQUITH, P.A.**
2. The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida, with the specific purpose of providing urgent care in advanced practice of nursing.
3. The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 100 shares of common stock, having a par value of \$1.00 per share.
3. This Corporation shall have perpetual existence commencing upon filing of these Articles.
4. The Registered Agent and the street address of the initial registered agent of this corporation in the State of Florida shall be: **SHARON JAQUITH, 971 Joiner Place, The Villages, Florida, 32162**, who by signature herein is accepting designation as Resident Agent.
5. The initial stockholders will be as follows:

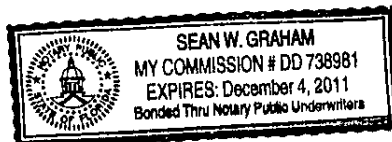

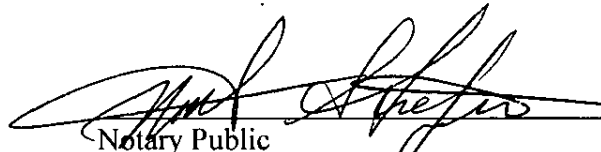
