

ARTICLES OF INCORPORATION OF

The undersigned, the authorized representative of the shareholders of the Company formed under Chapter 607, Florida Statutes (2002), adopts the following Articles of Incorporation for such Company (Henry Porter MD, Inc.):

ARTICLE I NAME
