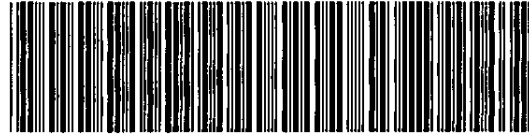



1. Introduction. Walter Kenzie Jr, being duly sworn, deposes and says:



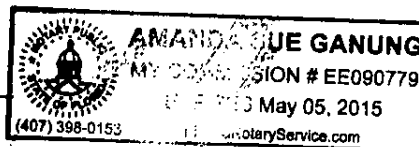


