

ARTICLES OF INCORPORATION OF

SECRETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned, acting as sole incorporator, adopts these Articles of Incorporation and forms a profit corporation (the "Corporation") under the Florida Business Corporation Act (the "Act"), as follows:

I. <u>Name</u>

The name of the Corporation is Aria Weddings & Events, Inc.

II. Term of Existence

The date when corporate existence will commence is June 20, 2011 in accordance with Section 607.0203(1) of the Act. The Corporation will have perpetual existence thereafter.

III. <u>Principal Office</u>

The principal office and mailing address of the Corporation is 17214 Keely Drive, Tampa, Florida 33647.

IV. Capital Stock

The Corporation is authorized to issue 1,000 shares of \$1.00 par value common stock, which will be designated Common Stock.

V. <u>Initial Registered Office and Agent</u>
