

ARTICLES OF INCORPORATION

FIRST: I, Joseph P. Nunemaker, II, whose mailing address is 4420 Northeast 16th Terrace, Oakland Park, Florida 33334, being at least eighteen (18) years of age, am hereby forming a profit corporation under and by virtue of the laws of the State of Florida.

SECOND: The name of the corporation (which is hereafter called the "Corporation") is
