The undersigned, acting as Incorporator of a Corporation pursuant to Chapter 607, Florida Statutes, adopt(s) the following Articles of Incorporation of such Corporation:

ARTICLE I - NAME AND PLACE OF BUSINESS

The name of the Corporation shall be:

CONECTA AMERICAS IMPORT, EXPORT AND SERVICES, INC.

ARTICLE II - TERM OF EXISTENCE

The period of the duration of this corporation is perpetual unless dissolved according to law.


