ARTICLE XI-AMENDMENT

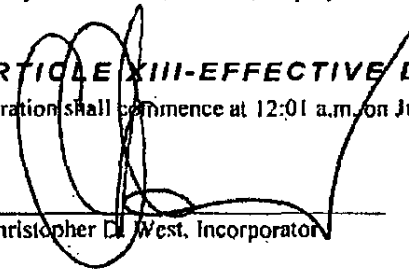

The existence of the corporation shall commence at 12:01 a.m. on June 23, 2011.

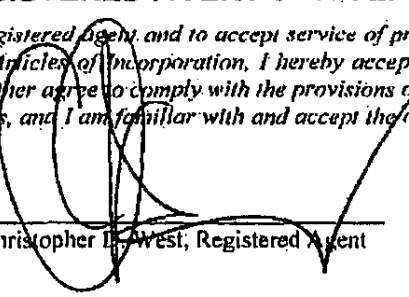
