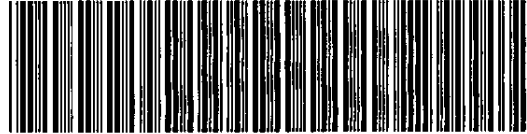

In compliance with the requirements of F.S. Chapter 607 and/or Chapter 621, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

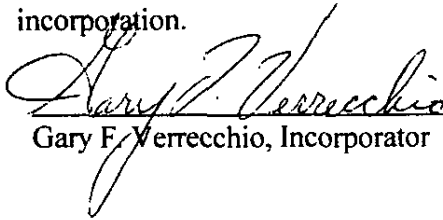

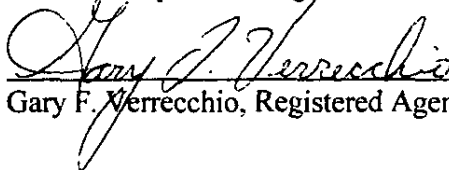
