Pursuant to the provisions of §607.1006 of the Florida Business Corporation Act, MEDYTOX MEDICAL MANAGEMENT SOLUTIONS CORP., a Florida corporation, adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is Medytox Medical Management Solutions Corp. (hereinafter called the "Corporation").
2. Article I of the Corporation's Articles of Incorporation is deleted in its entirety and replaced with the following new Article I:

"ARTICLE I

Corporate Name

The name of this corporation is Medytox Information Technology, Inc.
(hereinafter the "Corporation")."

3. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain unchanged.
4. The amendment made herein to the Articles of Incorporation of the Corporation was adopted by the written consent of the sole Shareholder, the number of votes cast for the amendment was sufficient for approval, and the Directors of the Corporation on the date of these Articles of Amendment, pursuant to Sections 607.0704 and 607.0821 of the Florida Business Corporation Act.
