**ARTICLES OF INCORPORATION OF
AZONE ENTERPRISES, INC.**

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1.

Name and Address

The name of the Corporation is Azone Enterprises, Inc. The principal office and mailing address of the Corporation is 27970 Crown Lake Boulevard, Suite 2, Bonita Springs, Florida 34135.

Article 2.

Duration

The duration of the Corporation is perpetual.

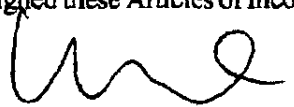
Article 9.

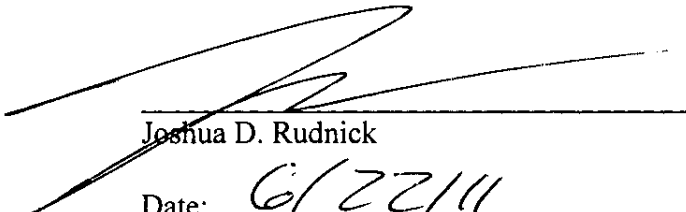
