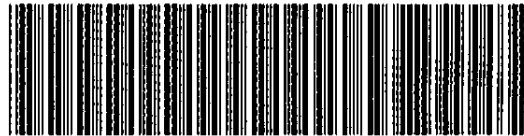



The name of the corporation shall be ZEAK TECHNIQUE, INC.


ARTICLE VI: REGISTERED AGENT


