ARTICLES OF INCORPORATION

OF

VRI MANAGEMENT SERVICES, INC., A FLORIDA CORPORATION

Pursuant to the provisions of Chapter 607, Florida Statutes, as amended, the following are hereby adopted and filed as the Articles of Incorporation of this Florida corporation for profit:

ARTICLE I - NAME

The name of this Corporation shall be: VRI Management Services, Inc.

ARTICLE II - INITIAL PRINCIPAL OFFICE

Said consideration is to be paid in cash or other property, tangible or intangible, or in labor or services actually performed for the Corporation.
