ARTICLE I.

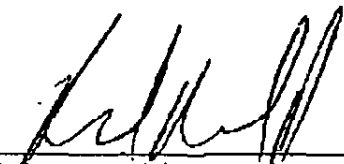
The name of the Corporation shall be:
