In compliance with the requirements of Florida Statutes Chapter 621 and Chapter 607, the undersigned hereby acts as incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a professional corporation.

#### ARTICLE I

The name of the Professional Corporation is: McDonald Chiropractic & Acupuncture, P.A.

#### ARTICLE II

The existence of the Professional Corporation shall begin on the date of filing of these Articles of Incorporation with the Florida Department of State.

#### ARTICLE III

#### ARTICLE IV
